#### About your project/what are you seeking funding for?

Troon Mens Shed is in the process of acquiring Hosiery Park Pavilion via CAT with SAC to become the new and permanent home of TMS. In terms of our developments plan we have engaged professional architects on the feasibility and redevelopment planning work involved to support and inform our CAT application and project development. We have already received the 1<sup>st</sup> phase of advice and feasibility support from our architects and have paid for this from existing TMS funds.

The next phase would be for our architects to prepare the relevant detailed planning application drawings and specifications for SAC to ensure our development plans in due course would receive approval by SAC Planning Dept. and in order for us to submit a formal offer to purchase the HPP building with confidence should we receive a successful outcome to our CAT application from SAC.

Troon is the Community, and Troon and surrounding areas are the main beneficiaries

## Please provide information you have about the need and support for the project, eg community consultation

The purpose of our Men's Shed is to provide recreational facilities and advance the social needs, health and well being of men of all ages and backgrounds living in Troon and surrounding areas. Troon Men's Shed was established in April 2024 and has a growing membership with 90 members as at 30 Aug 2025.

Fortnightly social meetings are currently held in The Lighthouse Christian Centre in Ailsa Road, Troon where tea and coffee are provided and guest speakers such as Prostate Scotland, Scottish Men's Shed Association, Fishermen's Mission, Troon Community Council, Troon Club 41 have given talks.

NHS Ayrshire and Arran have held an ageing well Functional Fitness MOT. Visits have taken place to UPM Caledonian Paper Mill and the Scottish Maritime Museum in Irvine.

Our members have volunteered to help out at community events in Troon; Wintertainment, Troon Round Table Fireworks and Santa Float.

We also supported (April 2025) Ayrshire Cancer Support with getting their new Ayr centre ready by moving items from storage, and assembling desks, tables, cupboards, sofas, chairs, putting up pictures and providing other volunteer assistance.

The acquisition of the Hosiery Park Pavilion will enable us to meet more regularly and undertake practical workshop activities which we are unable to do in a hired meeting hall.

A Stage 1 Community Asset Transfer Request was submitted to South Ayrshire Council in November 2024 and the informal Stage 2 request is currently being reviewed / finalised with a target formal submission date end of Sept 25.

The Hosiery Park Pavilion building is in poor condition as it has been unused for several years, and once acquired would be repaired and converted into a suitable facility comprising of a large multi-use social space for the use of TMS members and other local community groups when not in use by TMS, an activity workshop area where woodworking and other similar practical activities can be undertaken, and a small kitchen area for tea/coffee preparation for members and other user groups etc.
