#### What are the main activities/purpose of the group:

Harbour support people across Ayrshire by building relationships and empowering people to find solutions. We work in an integrated and collaborative way with key partners to provide holistic, abstinence based support that is responsive to need and quick in response. Our trauma informed approach in how we work with people is underpinned by kindness, trust and respect.

The Charity is led and staffed by a strong lived experience team whose focus along with its lived experience volunteers to ultimately save lives, improve life aspirations, keep families together and build stronger more resilient communities.

Our Board of Trustees, together with staff and volunteers are all affected by addiction in so many ways, with the vast majority having extensive lived experience and so grateful for being given the opportunity to give something back and give others the chance to get the second chance they have been given. This is a long term project creating a pathway and providing a support mechanism which in time with the support of many partners in the community help break the long term cycle of generational addiction.

Within South Ayrshire we have four support groups, two men's, 1 ladies and 1 family group, have two recovery practitioners offering 1:1 support across the community with a new enhanced service just started in Girvan and South Carrick, a community service vehicle supporting people fleeing violence and moving from temporary or otherwise unsuitable accommodation, a minibus offering support to beneficiaries with transport barriers to accessing support and an out of hours helpline.

Our work is structured in such a way that we aim to support our beneficiaries from a life of chaos and crisis through to positive destinations including further education, skills training and employment.

Purpose of grant application – please advise how the grant funding would be spent and how it would benefit recipients:

We are seeking grant funding to support the development and progression of our volunteers in South Ayrshire through our newly established Bridge to Shore project. This project has been carefully designed to invest in the future of individuals who have come through our support services, enabling them to move onto positive destinations such as employment, education, training, or further volunteering.

All our volunteers are individuals who have lived experience of addiction, mental health challenges, or social exclusion. After achieving six months of continuous sobriety and completing the 12-step process, they are invited to become Harbour Helpers—volunteers who support our activities including peer-led groups, crisis outreach, and community engagement. This structured transition is essential not only for their ongoing recovery but also for breaking cycles of dependency, debt, and poverty which affects all participants in various ways.

The grant would directly fund the training, mentoring, and support infrastructure needed to ensure these volunteers are equipped with the skills and confidence to move forward in life. This includes access to accredited training, trauma-informed support, supervised placements, and transport to activities, especially in rural areas where isolation is a significant barrier.

By investing in our volunteers, this funding will also create a sustainable pathway for new beneficiaries to step into volunteering roles as others progress to employment or education. This natural flow ensures continuity within our peer-led model and widens the impact across the community.

## The outcomes align directly with the aims of this fund via:

- Breaking the cycle of debt and dependency by supporting individuals to become self-sufficient and develop transferable life and employment skills.
- ➤ Reducing child poverty by enabling parents in recovery to secure stable futures and model positive change within their families.

- ➤ Reducing crisis through early intervention by empowering trained volunteers to support others at the earliest stage of need.
- ➤ Preparing people for employment, education, training, and volunteering through a structured progression pathway grounded in lived experience, resilience, and peer support.

This investment in volunteer development is crucial to our wider strategy of community recovery and social inclusion, ensuring that those who have once needed support are now key contributors to the wellbeing of others.
