### What are the main activities/purpose of the group:

Vics In The Community is a registered charity based in North Ayr and was established in 2018 with the aim of addressing inequality by supporting people living in poverty through football.

During the Covid-19 pandemic Vics became the main anchor organisation within North Ayr supporting young people, families and vulnerable adults with food, digital equipment, energy vouchers and other essentials.

Following the pandemic Vics have continued to provide a range of supports and interventions and have continued to work alongside both Public and Third Sector groups and organisation's including the local schools, Information and Advice Hub, Thriving Communities and Voluntary Action South Ayrshire to support people living in North Ayr.

Vics are recognised locally as the organisation who can provide support with white goods, food insecurity, fuel poverty, mental health and wellbeing support while also offering a range of football programmes across North Ayr.

Our Community and Wellbeing Team offer a range of opportunities for young people and adults to take part in groups including our Mindful Mondays, Men's Group, Chatty Spaces, Community Pop Up Events, Walking Football and ASN groups. The team also continue to support individuals referred or who have contacted the team direct for support.

Our football programmes include our organised teams for kids aged 4 years up to older adults playing walking football. There are currently over 370 people playing across our teams supported by our team of volunteers and staff.

Vics continue to offer free community football during the school holidays and these programmes continue to be well attended and supported by funders such as Cash For Kids and the Scottish Football Association. The football programmes offer young people the opportunity to play football and receive a healthy lunch snack while also supporting parents and carers with childcare.

In addition to the football camps Vics organise other opportunities for young people such as outdoor learning activities, fun days at NVP and trips.

Vics continue to respond to the ongoing needs and challenges across the community.

# Purpose of grant application – please advise how the grant funding would be spent and how it would benefit recipients:

Vics continue to be the cornerstone of the community supporting a wide range of people living in North Ayr particularly people living in Whitletts.

With the community being recognised as the most deprived Community in South Ayrshire and in the top 5% most deprived data zones in Scotland, it is evident that financial inclusion and wellbeing support is needed within the community. Unemployment remains higher than the national average and there continues to be challenges with drugs, alcohol and knife crime close to our base at NVP.

Vics are very fortunate to have received funding that has helped create a staffing resource who can provide support; however, the team require funding to be able to offer vouchers to support food and fuel poverty, support people in crisis, organise early intervention programmes/support for young people, adults and families and continue to support people with training that leads to volunteering and employment.

Our Community Team anticipate an increase in referrals and people engaging with Vics when our new Community Hub opens. The Hub will provide a new place/space where we can offer a range of activities such as cooking on a budget, mental health and wellbeing programmes and support for volunteers.

Funding will be used to assist, support and develop our work in North Ayr and funding will target people living in poverty including young people, adults and families.
